We write to bring to your attention the competitive application submitted by the Warren County Transportation Improvement District to the FY19 Better Utilizing Investments to Leverage Development (BUILD) grant program.

We understand that Warren County, in partnership with the Ohio Department of Transportation, the Warren County Board of Commissioners, and Turtlecreek Township, seeks funding for the State Route 63 Priority Project. This project would provide an improved link between I-75 and I-71 by widening the current two-lane road into four lanes, with a turning lane at the intersections and shoulders to improve traffic flow, and workspace for emergency crews after an accident.
