B. C. WCTID Program of Projects

1. I-71 / Fields-Ertel Mason-Montgomery Road Interchange Project

Mr. Dan Corey provided members with ODOT highlighted map articulating the multiple projects in this area. There is also chart on each project with funding source given. Ms. Thompson lead a discussion regarding the role of the WCTID Board with respect to the process of selecting Projects to designate, study for further action and development, and what determining factors are when choosing to place a new project on the WCTID Program and Projects list. Mr. Tunison responded to Ms. Thompson's questions regarding process and that the Board would see information on prospective the projects in advance for consideration and determination. Mr. Schuermann referenced the Board's Resolution 2011-05 which establishes the WCTID Program and Projects and outlines some predicates for consideration relating to WCTID Program Projects.

2. I-71 / Western Row Road Interchange Project

Mr. Corey stated that the status report would be discussed under new business due to the prospective TRAC application.

3. I-75 / at SR73 Interchange Project

Mr. Corey stated the I-75 at SR73 Interchange Project was on schedule and within budget. Andy Shahan, LJB stated comments have been received back from ODOT. Mr. Corey referenced a right-of-way diagram in the packet and stated that next Board meeting there would be two (2) resolutions presented to the Board for their consideration regarding putting two consultants under contract for right-of-way acquisition services.

Motion made by Mr. Eric Hansen and seconded by Mr. Bill Becker to authorize the the WCTID Secretary-Treasurer, on behalf of the WCTID Board of Trustees, to coordinate and collaborate with the City of Mason ("Mason") to submit a TRAC application for the I-71 Western Row Road Interchange Improvement Project and to proceed with the further development and preparation, in consultation with WCTID Legal Counsel, of an appropriate intergovernmental agreement between the WCTID and Mason relating to the implementation and funding of this WCTID Transportation Improvement Project to be brought back before the WCTID Board for further consideration and approval.
