Motion made by Ms. Tiffany Zindel and seconded by Mr. Neil Tunison to approve the minutes of the August 25th, 2017 Regular Board Meeting of the Warren County Transportation Improvement District as submitted. Ms. Christine Thompson abstained from voting. Upon roll call vote, motion carried with each remaining member present separately voting "yes" thereon.

C. WCTID Program of Projects:

Mr. Dave Mick and Mr. Dan Corey reported to the Board the following updates:

SB Entrance Ramp – WAR IR 71 0.00 (PID 100198)

Consultant continues designing the project through construction document phase.

Innovation Way Extension (Duke Blvd to Socialville-Fosters)

 Construction ~ 90% complete – completion date by contract – October 31st, 2017.

Duke Boulevard Widening (Irwin-Simpson to Innovation Way Extension)

Final plans submitted and under review. ROW negotiations continue.

Mason-Montgomery Road Widening

 Construction ~ 30% complete – completion date by contract – September 10th, 2018.

Western Row Road Interchange Improvements – Phase 1 (PID 95120)

 Construction ~ 95% complete – completion date by contract – December 29th, 2017.

Western Row Road Interchange Improvements – Phase 2 (PID 93964)

 Construction ~ 10% complete – estimated completion date – June 1st, 2019.

Innovation Way Widening

Construction ~ 40% complete - completion date by contract - October 31st, 2017, due to utility issues will be completed before the end of the year.

SR73/SR741 Intersection Improvements

 Construction ~ 25% complete – completion date by contract – July 1st, 2018.

SR48 and Mason-Morrow-Millgrove Road

 Construction ~ 40% complete – completion date by contract – September 30th, 2018, due to utility issues will be completed by July 31, 2018.

D. Financial Report

Mr. Neil Tunison presented the August 2017 Monthly Financial Report to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID. More specifically, the Monthly Financial Report detailed that as of August 31st, 2017 the General Fund had an ending fund balance of \$739,012.24 and the WCTID as a whole had an ending fund balance of \$30,248,184.90. Mr. Eric Reiners made a motion to accept the WCTID financial report as submitted, Ms. Christine Thompson seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

E. New Business

- 1. Warren County Transportation Improvement District Depository Banking Services Discussion. The Board discussed the Peoples Bank Depository Banking Services Proposal dated September 21st, 2017. The Board authorized the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute the documentation necessary to enter into an agreement with Peoples Bank for Depository Banking Services. Mr. Eric Reiners made a motion to approve and Ms. Christine Thompson seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- Resolution Number 2017-39, A resolution authorizing fund level transfers (amended and restated). Ms. Tiffany Zindel made a motion to approve the Amended and Restated Resolution and Ms. Christine Thompson seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- 3. Resolution Number 2017-42, A resolution approving amendment of Intergovernmental Agreement designating new funding with the Warren County Board of Commissioners. Mr. Eric Reiners made a motion to approve the Resolution and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 4. Resolution Number 2017-43, A resolution establishing a new fund. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- Resolution Number 2017-44, A resolution approving amendment of Fund Budgets for Calendar Year 2017. Ms. Christine Thompson made a motion to approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 6. Resolution Number 2017-45, A Resolution approving and authorizing acquisition of real property interests and construction services for the Mason-Morrow-Millgrove Road Relocation Project. Ms. Christine Thompson made a motion to amend and approve the Resolution and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 7. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2017-04 with Saturn Electric, Inc. dated August 1st, 2017 for the "Offices of Dr. Ball" work that is associated with the Duke Energy work for the SR73 and SR741 Intersection Improvements, with an increase in contract time through December 31st, 2017 with no increase in the contract price, made by Ms. Christine Thompson and Mr. Eric Reiners seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
