## D. Financial Report

Mr. Mark Hurst presented the May 2018 Monthly Financial Report to the Board. The Monthly Financial Report detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of May 31<sup>st</sup>, 2018 the General Fund had an ending fund balance of \$706,966.48 and the WCTID as a whole had an ending fund balance of \$21,137,362.21. Ms. Tiffany Zindel made a motion to accept the WCTID financial report as submitted, Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

- 4. Resolution Number 2018-20, A Resolution Approving and Authorizing Notice to Contractors and Acceptance of Bids for Construction Services for the Wilkens Boulevard Traffic Signals Project. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each remaining member present separately voting "yes" thereon.

Resolution Number 2018-21, A Resolution Authorizing Application for United States Department of Transportation FY 2018 "Build Transportation Discretionary Grants" Funding for Advancement of Transportation Improvement Project. Ms. Tiffany Zindel made a motion to approve the Resolution and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each remaining member present separately voting "yes" thereon.

Jergens Contractors, Inc. dated February 24<sup>th</sup>, 2017 for the "Innovation Way Roadway Widening", with an attendant increase in contract time through September 1<sup>st</sup>, 2018 and with no increase in contract price, made by Mr. Chris Pozzuto and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.

Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 02 to Consultant Agreement 2017-07 with PRIME AE Group, Inc. dated March 24<sup>th</sup>, 2017 for the "WAR-48-8.80 Mason-Morrow-Millgrove Road (PID 94494)", with an attendant increase in contract time through September 1<sup>st</sup>, 2018 and with no increase in contract price, made by Ms. Tiffany Zindel and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 8. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Contract Change Order 02 to Contract No. 16-03 with Ford Development Corporation dated December 15<sup>th</sup>, 2016 for the "INNOVATION WAY EXTENSION", increasing the contract price by \$619.77, making the new not-to-exceed amount under the Contract of \$4,063,280.37, with no attendant increase in contract time, made by Mr. Chris Pozzuto and Ms. Tiffany Zindel seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 9. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Contract Change Order 03 to Contract No. 16-02 with John R. Jurgensen Co. dated May 3<sup>rd</sup>, 2016 for the "PID 95120: WAR CR15 3.49 COLUMBIA ROAD RELOCATION (aka WESTERN ROW PHASE 1)", increasing the contract price by \$80,000.00, making the new not-to-exceed amount under the Contract of \$8,698,098.25, with no attendant increase in contract time, made by Mr. Neil Tunison and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 10. Motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 02 to Consultant Agreement 2015-10 with R L Record LLC, dated July 24<sup>th</sup>, 2015 for the "State Route 63 Scoping Study", increasing the contract price by \$3,700, making a new not-to-exceed amount under the Agreement of \$85,356.00, with an attendant increase in contract time through November 1<sup>st</sup>, 2018, made by Ms. Tiffany Zindel and Mr. Chris Pozzuto seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
