- Construction ~ 75% complete – completion date by contract – June 1, 2019

D. Financial Report

Mr. Mark Hurst presented the August 2018 and September 2018 Monthly Financial Reports to the Board. The Monthly Financial Reports detailed both monthly and year-to-date cash activities for all funds of the WCTID, and that as of November 30th, 2018 the General Fund had an ending fund balance of \$729,620.43 and the WCTID as a whole had an ending fund balance of \$15,002,597.30.
