B. Approval of Minutes:

January 30, 2015 Board Meeting: Motion made by Mr. Bill Becker seconded by Mr. Neil Tunison to approve the minutes of December 5, 2014 Annual Meeting of the Warren County Transportation Improvement District as submitted. Upon roll call vote, all members present each separately voting "Yes" thereon.

C. WCTID Program of Projects

- 1. I-71 and Fields-Ertel Road Interchange Area
 - a. NB Exit Loop Ramp (ODOT PID 87401)
 - Steel is being hung for the bridge the week of February 2nd (weather permitting) Completion targeted for October 2015
 - b. HAM CR 4 3.96 (ODOT PID 91060) (aka I-71 Safety Study)
 - No report
 - c. I-71 SB Entrance Ramp at Fields-Ertel Road
 - At the ODOT/WCTID Quarterly meeting discussions were had and a plan was developed on how the begin the process of a conceptual alternative study. More meetings are planned to occur in February, ultimately this will require an IMS
- 2. I-71 and Western Row Road Interchange Area
 - a. Overall Project
 - Due to TRAC Committee not being able to obtain a quorum, the vote for the final funding was delayed till February 26th.
 - Construction is scheduled for 2016 for Phase 1 and 2017 for Phase
 - b. Columbia Road Relocation Improvements Phase 1 (PID 95120)
 - ROW Acquisition Phase has begun
 - c. Western Row Road Interchange Imp. Phase 2 (PID 93964)
 - ROW Acquisition Phase will begin in 1st guarter of 2015

- 3. SR 73 Corridor
 - a. SR 73 and SR 741 Intersection (PID 95318) Improvements
 - Consultant team continues to develop the plans through the PDP process
 - b. I-75/SR 73 Ramp C (ODOT PID 92040)
 - Waterworks construction remains to be completed
- 4. SR 48 WAR-48-8.80 MASON MORROW MILL (ODOT PID 94494)
 - Right-of-Way Acquisition Team continues with front end work. No offers have been made.
 - Construction plans continue to be modified due to changes requested by Village of South Lebanon (intersection lighting), and utility conflict resolutions (sanitary sewers)
- 5. Southwest Warren County Area Improvements
 - a. Mason-Montgomery Road Corridor (CR21)
 - Construction Plans for SB Add Lane from Fields-Ertel Road to Parkway Drive are completed
 - b. Socialville-Fosters Road Corridor (CR 32)
 - Phase 1 Socialville-Fosters Road Widening and Bridge Replacement Project (Innovation Way to Columbia Road)
 Revised Stage 3 Plans are anticipated to be submitted February 1st.
 - c. Innovation Way Corridor (CR 383)
 - Widening of Innovation Way from Socialville-Fosters Road (CR 32) north to the SB Entrance/Exit ramps of I-71 as part of the Interchange project is being developed and hiring a consultant for the plans is part of New Business

E. **Financial Report** –Mark Hurst presented the December 2014 *Monthly Financial Report* to the Board. The *Monthly Financial Report* detailed both monthly and year-to-date cash activities for all funds of the TID. More specifically, the *Monthly Financial Report* detailed that as of December 31, 2014 the General Fund had a cash balance of \$771,046 and the TID as a whole had a cash balance of \$9,752,031. Mr. Bill Becker made a motion to accept the WCTID financial report as submitted, seconded by Mr. Neil Tunison. Upon roll call vote the motion carried with each member present separately voting "Yes" thereon.

Resolution No. 2015-01, A Resolution authorizing a Consultant Contract for Union/Greentree Road Intersection Improvement/WCTID No. 15-01 with CESO, Inc. in an amount not to exceed One Hundred Ninety Eight Thousand Seven Hundred Ninety-One Dollars (\$198,791.00). Ms. Christine Thompson made a motion and Mr. Bill Becker seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
- 3. Resolution 2015-02, A Resolution authorizing a Consultant Contract for Innovation Way Road Widening Improvements with Bayer Becker Engineering, Inc. in an amount not to exceed One Hundred Thirty-Eight Thousand Nine Hundred Twenty-Five Dollars and no cents (\$138,925.00). Mr. Neil Tunison made a motion and Ms. Christine Thompson seconded the motion. Upon roll call vote, motion carried with Christine Thompson, Dave Gully and Neil Tunison voting "yes" and Bill Becker "abstaining" from voting, thereon.
- 4. A motion to authorize the Secretary-Treasurer, in consultation with WCTID Legal Counsel, to prepare and execute Change Order 01 to Consultant Agreement 2014-01 with CT Consultants, Inc. dated February 28, 2014 for the "Socialville-Fosters Road Widening and Bridge Replacement Project/WCTID No. 14-01", increasing the contract price by \$34,400.00, making a new not-to-exceed amount under the Agreement of \$407,200.00 with no attendant increase in contract time. Mr. Bill Becker made a motion and Mr. Neil Tunison seconded the motion. Upon roll call vote, motion carried with each member present separately voting "yes" thereon.
